1. ALL SUBMISSIONS MUST REPRESENT THE ACTUAL ARTWORK AS CLOSELY AS POSSIBLE.
2. SUBMISSION IMAGES MUST BE ATTACHED. PREFERRED FORMAT IS JPEG.
3. ALL ENTRANTS GRANT *ART IN ACTION* THE RIGHT TO USE OR PUBLISH IMAGES OF THEIR WORK TO PROMOTE THE EVENT, FUTURE CALL FOR ENTRIES, OR VIDEOS.
4. ALL ENTRIES MUST BE THE ORIGINAL WORK OF THE ENTRANT AND MUST NOT INFRINGE THE RIGHTS OF ANY OTHER PARTY. THE ENTRANTS MUST BE THE SOLE OWNER OF COPYRIGHT IN ALL PHOTOGRAPHS ENTERED AND MUST HAVE OBTAINED WRITTEN PERMISSION OF ANY CHILDREN FEATURED UNDER 18 FROM PARENTS/GUARDIANS. ARTIST IS FULLY RESPONSIBLE TO OBTAIN ALL MODEL OR PROPERTY RELEASES.
